1. Enrolment and Attendance

- 1.1 An enrolment fee of \$44.00/year shall apply to each child.
- 1.2 An enrolment fee of \$55.00/year shall apply to a family.
- 1.3 Enrolment shall be for a full year.
- 1.3.1 If a student wishes to discontinue training, written notification must be received by week 10 of the relevant term.
- 1.3.2 Full term fees shall apply to a student wishing to discontinue training after the commencement of the term.
- 1.3.3 In the event of a serious medical condition, or unforeseen circumstances, other arrangements may be made.
- 1.4 Parents are requested to advise the school if a student is not attending class due to sickness, or for any other reason.
- 1.5 Students may make up classes missed due to illness by taking a class of a higher or lower standard on another day.

2. Fees

- 2.1 Fees shall be paid for the full term.
- 2.2 **Fees are payable by week three of each term.**
